Statement of reasons

Main Road, Tiddington – Limited waiting 30 mins No return 1 hour/No Waiting at any Time

To allow regular turnover at the local shops it is proposed to introduce a section of Limited Waiting along Main Street, this will preserve or improve the amenities through which the road runs.

Baker Avenue, Stratford – No Waiting at any Time

It is proposed to replace a section of 'No Waiting 9am – 5pm' with 'No Waiting at any Time' on Baker Avenue to allow the local bus service to travel along the road safely; this will allow the safe passage of through traffic.

Masons Road, Stratford – Disabled Badge Holders Only

It is proposed to replace a section of Limited Waiting adjacent to 23 Masons Road with a disabled bay. This will provide a dedicated bay in the area for residents, and avoid danger to persons or traffic

Saffron Meadow, Stratford – No Waiting at any Time

To facilitate the passage of through traffic, it is proposed that the existing restriction 'No Waiting 8am – 6pm' is replaced by 'No Waiting at any Time' along the entire length of Saffron Meadow.

Saffron Meadow, Stratford – No Stopping except buses

To improve the amenities of the area through which the road runs it is proposed to implement a bus stop clearway by virtue of the national Traffic Regulation Order (Schedule 7, Part 6 of the Traffic Signs Regulations and General Directions 2016).

A435 Slip Road/ B4101 (Blind Lane, Broad Lane and Beoley Lane), Aspley Heath – No waiting at any Time

To complement the existing restrictions on the A435 slip road which were installed by Worcestershire County Council it is proposed that the 'No Waiting at any Time' restriction is continued into Warwickshire.

High Street, Henley in Arden – Disabled Badge Holders Only

It is proposed to replace a section of Limited Waiting bays adjacent to 29 High Street with a disabled bay. This will provide a dedicated bay in the area for disabled residents and visitors, and avoid danger to persons or traffic

Station Road, Studley – Removal of “No Waiting”

It is proposed that the 'No Waiting' restriction linked to the Studley Car Boot Sale which is currently in force on Station Road be removed as it is no longer required. This will maintain or improve the amenities through which the road runs.

Station Road, Long Marston – Removal of “No Waiting at any Time”

Due to a change of demographic in the area the 'No Waiting at any Time' restrictions are no longer required it is proposed to remove the restrictions along the entire length of Station Road.

Various Roads, Gaydon – No Waiting at any Time

To correct an administrative error it is necessary to attach supplementary plans to the order. This will not result in any changes on street.

Various Roads, Southam – Various Restrictions

To correct an administrative error it is necessary to attach supplementary plans to the order. This will not result in any changes on street.
